SUPPLEMENTAL DECLARATON OF SCOTT STANLEY, ESQ.

Scott Stanley, Esq. hereby declares, pursuant to 28 U.S.C. §1746, that the following is true and correct:

1. I am an attorney and a member in good standing of the bar of the State of New York. I am a Staff Attorney in the Boston Regional Office of plaintiff Securities and Exchange Commission ("the Commission"). I make this supplemental declaration based upon my personal

knowledge as set forth below and in support of the Commission's *ex parte* motion for emergency relief.

- 2. I spoke today with John Soares, a Special Agent of the Department Homeland Security, Homeland Security Investigations ("HSI"), about the execution of a search warrant on the offices of TelexFree, Inc. and TelexFree, LLC (collectively "TelexFree") at 225 Cedar Hill Street in Marlborough, Massachusetts on April 15, 2014. During the exercise of the search warrant, a Bristol County Deputy Sherriff encountered Joseph H. Craft, the Chief Financial Officer of TelexFree, entering an office and attempting to grab a laptop and bag. Craft stated that he was a "consultant" helping TelexFree prepare for bankruptcy and that the laptop and bag were personal items. The Deputy Sherriff told Craft that he could not take the laptop and bag and that these items would subject to the search. HSI Agents searched the bag and identified ten Wells Fargo Bank, N.A. cashier's checks totaling \$37,948,296. Copies of these checks are attached as Exhibit 1. Nine of the checks were dated April 11, 2014 and were remitted to James M. Merrill, the former President and current 50% owner of TelexFree. Of these checks, five were made out to TelexFree, LLC totaling \$25,548,809, and one was made out to Katia B. Wanzeler (whom I understand to be Carlos Wanzeler's wife) in the amount of \$2,000,635. One of the ten checks was dated April 3, 2014, and was remitted to Carlos Wanzeler, co-owner and treasurer of TelexFree, Inc., and co-owner of TelexFree, LLC. This check was made out to TelexFree Dominicana SRL in the amount of \$10,398,000.
- 3. On or about April 16, 2014, I spoke with a representative of Waddell & Reed Financial, Inc. She told me that, on April 15, 2014, at 7:30 a.m., James M. Merrill, submitted an unsolicited order to sell \$1,150,000 of his mutual fund holdings at Waddell & Reed and to
