On 05/18/2014 did, directly or indirectly, wilfully threaten, attempt or cause physical injury, emotional injury, economic injury or property damage to; or did convey a gift, offer or promise of something of value to; or did mislead, intimidate or harass another person who was a witness or potential witness at some stage of a criminal investigation, grand jury proceeding, trial or other criminal proceeding of some type; or a person who was aware of information, records, documents or objects that related to a violation of a criminal statute, or a violation of conditions of probation, parole or bail; or a person who was a judge, juror, grand juror, prosecutor, police officer, federal agent, investigator, defense attorney, clerk, court officer, probation officer or parole officer; or a person who was furthering a civil or criminal proceeding of any type, or a probate and family proceeding, juvenile proceeding, housing proceeding, land proceeding, clerk s hearing, court ordered mediation, or other civil proceeding; or a person who was attending or had made known his or her intention to attend a civil or criminal proceeding of any type, or a probate and family proceeding, juvenile proceeding, housing proceeding, land proceeding, clerk s hearing, court-ordered mediation, or other civil proceeding, with the intent to impede, obstruct, delay, harm, punish or otherwise interfere thereby, or do so with reckless disregard, with such proceeding, in violation of G.L. c.268, § 13B(1).

PENALTY: state prison not more than 10 years; or jail or house of correction not more than 2½ years; or fine not less than \$1000, not more than \$5000; or both. District Court has final jurisdiction under G.L. c.218, §26.
